

By registering, you (the "Participant") accept these Terms and Conditions of Registration and Participation of the "MWM Energy Days" on November 12 and 13, 2025 at the Congress Center Rosengarten in Mannheim.

The organizer of the "MWM Energy Days" is Caterpillar Energy Solutions GmbH, Carl-Benz-Str. 1, 68167 Mannheim, Germany (hereinafter referred to as "CES").
congress & more Klaus Link GmbH, Festplatz 3, 76137 Karlsruhe, Germany (hereinafter referred to as "congress & more") will take care of the Participant management on behalf of CES.

Participation

The number of Participants for the event is limited. Participation is only possible with a valid ticket. Registrations will be taken into consideration in the order of receipt. Participation cannot be demanded. Event tickets can be transferred to selected end customers, to other companies (subject to confirmation by CES), or to employees of your company. CES reserves the right to reject the selection. In this case, the event fee will not be refunded.

Registration will also be possible on site, subject to availability.

The admission control will take place at the entrance to the venue. The event organizer reserves the right to reject registrations.

Information Concerning the Registration

Make sure you spell your e-mail address correctly, since it will be used for all communication. This registration takes place exclusively via the event website

If the tickets are transferred to an end customer or distributed to employees of your company, the respective end customer/employees need to register additionally. For this, you will receive a code by e-mail, which you need to forward to the respective end customer/employees. By means of this code, the end customer/employees will get access to a registration link.

Registration Confirmation

Registrations constitute a binding offer and will be taken into consideration in the order of receipt. The contract with CES for the booked participation in the event comes into existence upon receipt of the registration confirmation/invoice from congress & more. If the tickets are transferred to one or several end customers/employees of your company, the contract with CES comes into existence upon receipt of the invoice of congress & more for the tickets purchased.

Fees/Payment

If you have not already paid by PayPal or credit card, the event fee will be due upon receipt of the invoice and shall be paid within 14 days of receipt. If the event fee is not paid on time, the right to participate will expire. In the event of loss of the ticket, **a fee of €20.00 will be charged for a replacement ticket.**

Cancellations

Cancellations must be made in writing (by e-mail to keppler@congressandmore.de).
In the event of cancellation, 100% of the event fee shall be due.
Costs for services not used will not be refunded.

Moreover, the participation fee will not be refunded if the Participant does not show up or leaves early. CES reserves the right to postpone or cancel the event in case the minimum number of Participants is not reached or for other organizational reasons. The Participants will promptly be informed of this. Any event fees already paid will be refunded. No further claims can be asserted. We reserve the right to change or postpone the event, dates, program, content, and speakers.

Data Protection

The data transmitted during the registration will be processed by congress & more and CES. The transmitted Participant data will be processed in compliance with data protection regulations.
